CHOICES UPDATE: GROUP 3 EXPANSION

The TennCare Choices Program provides managed long-term services and supports for individuals age 65+, or disabled, who need nursing home level of care. The care can be provided in a nursing facility (CHOICES Group 1) or with a suite of Home and Community Based Services (HCBS) delivered to their home, or to an assisted living facility (CHOICES Group 2).

CHOICES also provides a more moderate suite of HCBS to those considered 'at risk' of needing nursing home level of care (CHOICES Group 3 – CHOICES At Risk Demonstration Group). Group 3 is available to adults 65 and older or 21 and older with a physical disability receiving SSI (Supplemental Security Income) payments from the Social Security Administration. Effective October 1, 2022, an additional 1,750 slots will be open to non-SSI recipients.

Requirements for CHOICES Group 3 eligibility, beginning October 1:

*Age 65 or older, or 21 and older with physical disabilities.

*Meet TennCare's financial eligibility

standards for CHOICES (income no more than 300 percent of the SSI federal benefit rate (\$2523 per month), resources no more than \$2,000). *In the absence of CHOICES services and supports, would be at risk of requiring care in a nursing home.

Services in CHOICES Group III are covered up to \$18,000 per calendar year. Some of the covered services include:

- *Attendant care in the home
- *Respite care
- *Short-term nursing facility services
- *Assistive and enabling technology

*Minor home modifications

*Home-delivered meals

This expansion to CHOICES Group III is expected to increase enrollment in Group 3 by 1,750 persons, at an increased expenditure of \$58.8 million.

EBT CARD SKIMMING

The Tennessee Department of Human Services (TDHS) has issued a warning about increased theft of SNAP and TANF benefits through EBT card skimming. Card skimmers are stealthy fraud devices that collect or copy card information when a card is swiped or scanned for payment. The thieves then spend down the stolen funds, often before the rightful owner is even aware that their account has been breached.

The two best ways to prevent your EBT cards (as well as personal credit and debit cards) from being illegally accessed and the benefits on them from being stolen are frequently changing your PIN and checking your balance regularly, and learning to recognize what card skimmers look like. If your SNAP or TANF EBT card is compromised, TDHS recommends taking the following steps immediately. 1. Call EBT customer service at 1-888-997-9444 to report the card stolen and have it deactivated and replaced.

2. File a report with your local law enforcement agency.

3. Call the TDHS Fraud Hot Line at 1-800-241-2629 to report the incident.

FREE CAREGIVERS WORKSHOP SERIES WITH MUSIC ENHANCEMENT

Over 43.5 million family caregivers in America provide a vast array of emotional, financial, nursing, social, homemaking and other services to loved ones on a daily or intermittent basis. Many are caregivers of adults living with dementia or Alzheimer's disease. This is an incredibly stressful responsibility, but if family caregivers learn to take good care of themselves, they will be better prepared to take good care of their loved ones.

Powerful Tools for Caregivers is a free six-week program that meets once a week and is designed to provide the tools you need to take care of yourself.

Experienced facilitators will help participants learn about these tools and then put them into action. *TN M.I.N.D.S.* (Music Intervention Navigating Dementia Symptoms) is an added component that allows trained volunteers to work with the person who is living with dementia to create a personalized music playlist to help increase socialization, communication, and quality of life.

Join us on Fridays from January 13th through February 17th from 1:00pm to 2:30pm at Memorial Park Community Center, 510 Bert Street, Johnson City. Workshop space is limited to 12 and registration is required. The workshop is open to the public and is free of charge, so reserve your spot now.

NEW FTAAAD GRANT AWARDED

The First Tennessee Area Agency on Aging and Disability is proud to announce that they are the recipients of an invitation-only \$5,000 grant from The Community Foundation of Middle Tennessee as part of their Serving Tennessee Seniors grant bequest.

With this grant, FTAAAD will be purchasing Joy for All robotic cats, dogs and birds, which will be made available for distribution to adults over age 60 with dementia or other conditions that would benefit from the comfort a pet would normally provide. FTAAAD has previously used the robotic pets in partnership with Alzheimer's Tennessee to great success.

The remainder of the grant money will be used to purchase portable SafeAwake Smoke Alarm Aid Bed Shakers and compatible smoke alarms for older adults with hearing loss who may be unable to hear a standard smoke alarm in case of fire. These purchases emphasize FTAAAD's ongoing commitment to assisting older Tennesseans and adults with disabilities with information and services that promote quality of life and independence.

TENNCARE RENEWALS

Congress has passed legislation which will end the Medicaid continuous enrollment requirement related to the COVID-19 pandemic on April 1, 2023.

Over a twelve-month period, TennCare will review every member's eligibility and use available data sources, such as Internal Revenue Service (IRS) income data and Supplementation Nutrition Assistance Program (SNAP) information, to automatically renew members. If TennCare cannot autorenew a person's coverage using available and approved data sources, the member will receive a pre-populated renewal packet by mail or a notification by email, depending on the selected preference.

If you have consumers enrolled in this program, please encourage them to confirm that TennCare has their most recent contact information on file to avoid any interruptions in service. For more information, go to www.tn.gov/tenncare/renewals.
